#### Participant survey:

Certificate II in Retail Services cohorts who provided the highest response rate (78.87%) whilst Certificate IV of Retail Management provided the lowest response rate (3.25%). The response rate of Certificate II in 2019 is lower to the response rate in 2018 (78.87% in 2019, 85.37% in 2018)

Employer survey: Employer survey in 2019 is higher than 2018 (28% in 2019, 4.65% in 2018)



#### Section 2 Survey information feedback

#### What were the expected or unexpected findings from the survey feedback?

We expected positive responses for both participant and employer survey. Most of strongly agree responses have increased in 2018 compared to 2017

#### Participant survey indicated that

- Participant developed knowledge expected (47.40% agree + 46.75% strongly agree) and skill expected (49.35% agree + 43.51% strongly agree) from the training.
- Facilitator had excellent knowledge (30.52% agree + 66.23% strongly agree) & facilitator made the subject interesting (37.01% agree + 59.09% strongly agree).
- The training had good mix of theory and practice (46.75% agree + 44.81% strongly agree), assessment were based on realistic activities (48.70% agree + 48.05% strongly agree) and the training prepare well for work (46.10% agree + 46.75% strongly agree).

#### Employer survey indicated that

- Trainers were effective in their teaching (53.33% agree + 40% strongly agree) & trainer had good knowledge and experience (60% agree + 40% strongly agree)
- Training prepared employees well for work (60% agree + 40% strongly agree) & training was an efective investment (60% agree + 33.33% strongly agree)
- Training resources were appropriate for learner needs (66.67% agree + 26.67% strongly agree) & RTO acted on feedback from employers (86.67% agree + 13.33% strongly agree)

#### What does the survey feedback tell you about your organisation's performance?

- Participant were satisfied with the training (44.16% agree + 46.75% strongly agree) and would recommend the RTO to others (40.91% agree + 48.05% strongly agree)
- Overall the employers were satisfied with the training (73.33% agree + 20% strongly agree) & would recommend RTO to others (73.33% agree + 20% strongly agree)

#### Section 3 Improvement actions

#### What preventive or corrective actions have you implemented in response to the feedback?

In order to maintain positive response rate of good facilitation from trainer, we run regular facilitators meeting to receive feedback and provide training anda ssessmeetnr ecommendations. We facilitate the discussion among the



faciltiators to trigger innovation and improvement in the training delivery area.

#### How will/do you monitor the effectiveness of these actions?

Continuous improvement meeting is being held every 4<sup>th</sup> week each month to ensure the action items, as results of operation changes and validations, are monitored and communicated to both internal and external team across the states.
